By making a booking with *Rewilding Adventure* you are entering a contract; in doing so you guarantee that you have the authority to do so and that you accept these booking conditions. If making a booking on behalf of a group, you agree you have their authority,or where participants are under 18 years old, their parents'/guardian authority.

## **The Booking Conditions**

### **Disclaimer:**

'By making a booking, you accept that, by its nature there are inherent risks when participating in Forest School, outdoor learning, bushcraft, targetsports and greenwood working (all activities deleivered by Rewilding Advneture); by participating you understand the steps that have been taken to minimise these risks, and agree to follow the guidance of the instructors. You also acknowledge that those attending are physically fit and healthy enough to participate, and will make the instructors aware of any medical concerns you feel are necessary in the circumstances. You are aware of the limitation of the insurance cover (£5m). You participate/make the booking with the understanding that Rewilding Adventure are not liable for any loss, damage, injury or expense now or in the future from participating in activities. Please bring any medical issues, dietary needs, food intolerances or allergies to the attention of instructors'.

## Liability

- Although *Rewilding Adventure* have a good record of safety, as well as having a Health & Safety policy and risk assessments- the activites provided have an element of risk by their very nature. By making this booking you accept this risk
- Rewilding Adventure takes no liability for lost or damaged property; outdoor learning takes place in wild and remote settings, and the activities undertaken can result in routine wear and tear to personal property and clothing occurring (please be aware that by the nature- there is a risk of damage to clothing due to being close to a fire and using tools).
- By making this booking you take responsibility for your actions, your children's actions and if making the booking on behalf of a group you also take responsibility for their actions
- Any losses of *Rewilding Adventure*'s property, or wilful damage to it, will be charged to the person making the booking (or their organisation)
- If you are booking on behalf of a group where other staff will attend as part of their employment or in a voluntary capacity, you acknowledge that you will inform them of the above

#### **Health & Safety**

- Much of the work of *Rewilding Adventure* takes place in woodlands, hills, mountains and wild places, as such we are unable to ensure that all locations are engineered to be wholly free from slip, trip or fall hazards- nor can we be reaosnably expected to do so in a natural setting
- Outdoor activities require a level of fitness and will entail exertion; if you have medical concerns you agree to consult a doctor prior to attending; if relevant you will advise *Rewilding Adventure*
- Where *Rewilding Adventure* will act in loco-parentis, we require '*Particicpant Information Forms*' to be returned (and signed by a parent/guardian if under 18years) or an agreement to produce them on the day is made
- If a 'Particicpant Information Form' is not returned that particicpant may not be able to take part but will still be liable for the fee
- Participants' behaviour must not prejuidce health & safety, if it does *Rewilding Adventure* reserves the right to remove them from the activity; they will still be liable for the fee
- All activities will be conducted in accordance with National Governing Body and professional qualification guidance and good practice; relevant qualifications are available upon request
- Participants (and parents/guardians for those aged under 18 years) should be cognisant with the inherrent risk of outdoor activitits; in many cases the engaging in such activites will done in order to develop particpants' awareness and management of risk- particualry during Forest School and bushcraft activites
- The consumption of alcohol is strongly adviswd agaisnt during activities which are ran by *Rewilding Adventure* as there is a need for concentration and co-ordination, if instructors have concerns that a participant is under the influence of alcohol or controlled substances to an extent where safety is put at risk 3then they may be removed from activites, or the activities may be suspended
- *Rewilding Adventure* are committed to an ethos of positive risk awareness rather than risk aversion; in many cases a risk/benefit analysis will be conducted for the activites undertaken

#### Insurance

• *Rewilding Adventure* have liability cover to a values of £5m; this does not include personal accident, travel or cancellation cover

#### **Cancellations and modifications**

- *Rewilding Adventure* reserve the right to modify or postpone bookings due to safety concerns or factors which lie beyond their control (a *Force Majeure*): for example, extreme snow fall or gale force winds (please note, such a change is not a cancellation but a modification)
- Adverse and foul weather contingencies will be considered according to the activities booked; where possible this will be done in consultation with the booking party. *Rewilding Adventure* will not jeopodize safety due to the weather conditions
- Booking cancellations will be payable by the booking party with specified timescale prior to the activity, the timscales are:
  - More than one month- no fee
  - o Under one month- 25%
  - Within 2 weeks- 50%
  - Within 1 week- 75%
- Any liability for cancellation fees incurred through the booking of third party venues/accomodation will be transferred to the party making the booking
- If cancelled by *Rewilding Adventure* prior to activity taking place, *Rewilding Adventure* will either rearrange for an alternative mutually convenient date or provide a full refund; in these circumstances you have the choice

#### Fees

- Deposits, Fees and expected payment dates are detailed on the invoice
- The fee payable is the activity fee plus any expenses incurred (which will be detailed to you prior to booking)
- *Group Bookings* are charged as a block rate, rather than a price per person; a price per person will be included for information, but the cost is chargeable as a whole
- You agree to pay these fees within stipluated dates as detailed on the invoice
- Additonal deposits may be required in circumstances where expenses (greater than £30) will be incurred by *Rewilding Adventure*
- Payment will be in cash, BACS (preferred), Paypal, Card Payment or cheque (made payable to 'Rewilding Adventure')
